MINUTES

A. CALL TO ORDER

The meeting was called to order at 4:04 p.m. by Commissioner Meursing.

B. ELECTION OF OFFICERS

MOTION: Commissioner Riffle moved that status quo be maintained, retaining Commissioner Meursing and Chairman and Commissioner Riffle as Vice-Chair. The motion was seconded by Commissioner Wilmot. **Motion passed 3 – 0**

C. PUBLIC COMMENT

Virginia Lester, as Chairperson of PREP wanted to thank Chief Carleton for arranging for PREP and CERT organizations to be invited to participate in final burn of the home on Marine Drive. Chief responds by thanking the two organizations, and the public, for participating and viewing this valuable training exercise for our members.

D. BOARD ACTION

D.1 Approval of the Minutes of the Regular Meeting of December 9th, 2015

MOTION: Commissioner Riffle moved to accept the Minutes of the December 9th, 2015 regular meeting as read. The motion was seconded by Commissioner Wilmot. **Motion** passed 3–0.

E. FINANCIAL MANAGER'S REPORT

E.1 Financial Report

Financial Manager Markel provided an overview of her report.

E. 2 Approval of Fire District Vouchers

MOTION: Commissioner Riffle moved to accept the Vouchers for December, 2015 in the amount of \$32,694.58 for payment. The motion was seconded by Commissioner Wilmot. **Motion passed 3** - 0

E.3 Approval of Fire District Payroll

MOTION: Commissioner Riffle moved that the payroll in the amount of \$13,928.67 be approved for payment. The motion was seconded by Commissioner Wilmot. **Motion passed 3 – 0**

E.5 Budget Update

Financial Manager Markel provided an overview of the current budget status, indicating that it appears year-end 2015 will close with approximately 6.23%, or \$33,000.00, of the budget remaining.

Commissioner Meursing wanted to discuss the cost of living increase (CPI) for Chief Carleton's employment contract, effective January 1, 2016. Financial Manager Markel indicated that the most recent CPI rate is 1.5%. Chief Carleton clarified that the CPI component of his employment contract is from June to June, with any increase to become effective January 1st the following year, and since the rate in June of 2015 was 1.1%, any CPI increase should be 1.1%, and not the current rate of 1.5%. All Commissioners discussed this clarification and instructed Financial Manager Markel to begin including the CPI rate increase of 1.1%, effective January 1, 2016, toward Chief Carleton's remuneration.

F. CORRESPONDENCE

Correspondence included several holiday cards, including one \$100.00 donation to WCFD5. The donation was deposited to the General Fund and the Chief noted his appreciation for such donations from community members.

G. CHIEF'S REPORT

Chief Carleton provided an overview of the Chief Officer Report as attached and scanned.

The Chief continues to remind homeowners to contact their insurance companies to seek potential savings related to the District's improved ISO rating.

The Chief also gave an overview of the status of the grant applications that he has been preparing and will be filing at the end of this week.

Chief also reviewed the number of members in the organization, advising that approximately 14 members have left the district over the past year to career positions in Canada. He described the district as being a farm team, and he is proud of that. Our organization is known for its high level training and while members seeking career positions may not stay with us for long, the community benefits from their enthusiasm and willingness to volunteer here. New members from outside our community must take all their own firefighter 1 and firefighter 2 certification training, at an expense of approximately \$16,000 to \$20,000, a cost that the District does not bear. Chosen Point Roberts applicants' training is paid for by our District and those members enter into a contract with the District which includes repayment of some training costs if a pre-determined length of service is not completed, and for firefighters that term is two years. Chief thanked the Canadian volunteers that choose to develop their career here and protect this community in the process.
