Current month payables total \$ 16027.42 which includes a couple of items to point out:

Volunteer payouts that are included in warrants total \$2658.00 This reflects September 2014 activity. Chief Carleton and I did a 2014 payroll audit thru July in September and found one issue of \$13.00 which is being corrected in this payroll.

There is a payment to Shell Oil for \$1069.00, a payment to US Bankcorp (our credit card) in the amount of \$7018.63. On the bill are three items of interest, a payment to Engel for \$1135.94 for a medical fridge, a payment to Life Assist for medical supplies in the amount of 1340.15 and a payment to Keiser Corp for a fitness bike for 1721.00.
