Regular Meeting of the Board of Commissioners

December 13th, 2017

MINUTES

A. CALL TO ORDER

The meeting was called to order at 4:01 p.m. by Chairman Meursing, who recognized former Commissioner Stanley Riffle in attendance.

B. OATH OF OFFICE of Pat Harper, WCFD5 Commissioner Position #3

Pat Harper took the Oath of Office, executed the document and notarized by Julia Carlson, which will be forwarded to the State Auditor.

C. PUBLIC COMMENT

Chief Carleton welcomed Commissioner Pat Harper to the Board.

Vic Riley congratulated Pat Harper on his electoral victory and welcomed him as the newest commissioner of the Fire District.

D. BOARD ACTION

D.1 Approval of the Minutes of the Regular Meeting of November 8th, 2017

Commissioner Meursing suggested a change to the Minutes of the Regular Meeting of November 8, 2017 to include "review of performance evaluations" to the Motion put forward by Commissioner Tomsen to enter into Executive Session.

MOTION: Commissioner Lester moved to accept the Minutes of the Regular Meeting of November 8th, 2017 as amended. The motion was seconded by Commissioner Meursin. **Motion passed 2–0. Commissioner Harper abstained.**

E. FINANCIAL MANAGER'S REPORT

E.1 Financial Report

Financial Manager Markel presented the monthly financial report as submitted.

Commissioner Meursing asked about the expenditure to 511 Tactical. Chief responded it was for clothing. Commissioner Meuring also asked about West Coast Fire (extraction tools on display) and Sire Net (scene lighting). Chief reminded the Commissioners that both of these latter expenditures were part of the capital improvements earlier approved.

Commissioner Lester asked about the expenditure to Action Training, and one seemingly high payment to a District member. Chief responded the first was for online continuing education and the second was for a member who had recently obtained his I-10 and was entitled to receive all stipends accumulated from the start of this year. Chief reported that about a dozen other members who would have been entitled to stipend payouts did not receive their I-10 prior to this meeting, their last chance to be eligible to be paid accumulated stipends. Those stipends are now expired.

Commissioner Meursing asked about the expenditure to Northwest Fire Rescue and Chief explained that was for the last training burn. He also indicated that the expenditures to Radio Recognition was for clothing and to Life Assist was for medical supplies.

E. 2 Approval of Fire District Vouchers

MOTION: Commissioner Lester moved to accept the Vouchers in the amount of \$57,363.20 for payment. The motion was seconded by Commissioner Meursin. **Motion passed 2** - **0 Commissioner Harper abstained.**

E.3 Approval of Fire District Payroll

MOTION: Commissioner Lester moved that payroll in the amount of \$20,383.34 be approved for payment. The motion was seconded by Commissioner Meursing. **Motion passed 2** - **0 Commissioner Harper abstained**.

E.4 Budget Update

Financial Manager Markel reported the budget update for 2017, as of November 30th, shows 14.44% remaining, compared with 18.4% in the same period last year.

Financial Manager Markel announced that she will be next be in Point Roberts for the regular February meeting, and reported that she would present tentative year-end financial results by teleconference at the regular January meeting.

Commissioner Lester asked Financial Manager Markel to identify the \$27,000 in additional income. Financial Manager Markel reported that EMS Transport fees to the District amounted to \$20,399.80, received as additional income and not part of the annual budget, and also the \$12,000.00 rebate from the IRS reimbursing the District for collected FUTA. There is also additional income from burn permits and other miscellaneous sources not relied upon when the annual budget is being prepared.

F. CORRESPONDENCE

Chief Carleton reported that there is no correspondence to report on as received in November.

G. CHIEF'S REPORT

Chief Carleton's Chief Officer Report was read and submitted, including:

There are 4 new members and 6 potential candidates currently being screened. He expects that the District will lose 6-10 members to career firefighting organizations in early 2018.

There are 8 new CPR instructors. He reminded the public that the District holds CPR instruction on the second Monday of every month, at the firehall, which is open to the public and is free, or \$5.00 for recipients who wish to receive a certification card.

The Chief reported on the calls for the month and of particular note is that there were no illegal burns in the month of November. Chief Carleton thanks the community for burning responsibly and obtaining the necessary permits.

Chief reported a callout to investigate a large cylinder that had washed up on shore. It was not a dangerous item so there is nothing further to report. He noted that the District has been called to the shore to respond to unexploded ordinance on the beach, often they are boater or Coast Guard flares washed overboard.

Chief reported a stand-by call to potentially attend the landing of a plane in distress; however no request for service followed.

H. UNFINISHED BUSINESS

I. NEW BUSINESS

Chief Carleton indicated that there were a number of scheduling conflicts in the New Year with his travel calendar and District meetings, however Assistant Chief Shields will likely be available to attend the meetings that Chief Carleton is unable to attend. In particular the Budget Workshop Special Meeting is usually held in late October, between the regular October and November meetings, and he indicated that he would be away for a period of time. Chairman Meursing suggested that discussion of that be postponed to later in the new year when the Budget Workshop meeting is being considered for scheduling. Chief noted that he is scheduled to be away for the November Regular Meeting, which is the Budget adoption meeting. After discussion and consultation with calendars, it was unanimously agreed to reschedule the November Regular Meeting to Wednesday, November 7th, 2018.

J. ADJOURNMENT

As there was no further business, Commissioner Meursing moved to adjourn the meeting at 4:32 pm. Commissioner Harper seconded the motion. **Motion passed 3** – **0**
