#### F. CHIEF'S REPORT

Chief Carleton provided an overview of the Chief Officer Report as attached and scanned.

At the conclusion of the Chief's Report, Commissioner Riffle introduced the topic of the Burn Ban sign located at the entrance to Point Roberts just after the border crossing, as some community members have voiced the opinion that the sign may be in contravention of the community character plan. Chief Carleton acknowledged that the Burn Ban sign is more noticeable than the Whatcom County sign but reported that illegal burns are down by half since the implementation of the Burn Ban sign at that location.

Chief maintains that the sign is an imperative public safety service and will remain in place. After discussion it is agreed that all Commissioners are in favor of keeping the sign.

#### H.1 Financial Manager Position

Patty Markel introduced herself. She has been the finance administrator for Whatcom County Fire District 7 for 16 years. She is familiar with the programs and the style of reports that WCFD5 generates, and has experience with fire district audit process.

An employment contract was presented for consideration. Discussion ensued about experience, suitability of the candidate, contract structure and the District's attorney involvement.

**MOTION:** Commissioner Riffle moved to accept the Employment Contract with Patty Markel for the position of Finance Manager for WCFD5. The motion was seconded by Commissioner Wilmot. **Motion passed 3-0** 

Patty Markel was welcomed to the organization by all.
