Commissioner Newmen asked about the District credit card, for which expenses it is used, and protocol for use. Assistant Chief Shields replied that the card is used for expenses such as training class tuitions, Delta Cable, Verizon, Puget Power, training manuals and other expenses. He explained the use of Vendor numbers to pay most service providers to taxing districts, and added that sometimes service providers do not have a Vendor number and the credit card is used to facilitate payment of those expenses. He also noted that the Chief has a spending limit on the District's credit card, and that the card earns cash back points with use.

Financial Manager Markel reported the budget update, as of May 31, 2019, has 67.79% remaining in the budget compared with 65.55% remaining in the same period last year.
