#### A. CALL TO ORDER

The meeting was called to order at 4:03 p.m. by Chairman Meursing.

#### C. BOARD ACTION

# C.1 Approval of the Minutes of the Regular Meeting of July 11, 2018

**MOTION:** Commissioner Lester moved to accept the Minutes of the Regular Meeting of July 11, 2018 as presented. The motion was seconded by Commissioner Harper. **Motion passed 3 - 0.** 

#### D. FINANCIAL MANAGER'S REPORT

#### D.1 Financial Report

Financial Manager Markel presented the monthly financial report as submitted.

#### D. 2 Approval of Fire District Vouchers

**MOTION:** Commissioner Meursing moved to accept the Vouchers in the amount of \$52,183.58 for payment. The motion was seconded by Commissioner Lester. **Motion passed 3** - **0** 

#### D.3 Approval of Fire District Payroll

**MOTION:** Commissioner Meursing moved that payroll in the amount of \$16,151.33 be approved for payment. The motion was seconded by Commissioner Lester. **Motion passed 3-0** 

#### D.6 Budget Update

Financial Manager Markel reported that due to technical difficulties the budget update for the July financial statements will be available in September, or sooner, and will be made available to the Commissioners as soon as possible.

Financial Manager Markel also reported that during the July meeting, the Commissioners approved a Resolution to Void a Lost Warrant in the amount of \$750.00 to NWFRS, which was subsequently found, and therefore the July warrants were reduced to \$19,264.52

Commissioner Lester asked for clarification of the warrant in the amount of \$27,391.00, and then realized it was to pay for the District's annual insurance policy as had been approved at the July meeting.

#### E. CORRESPONDENCE

Assistant Chief Shields reported that there is no correspondence to report at this time

#### F. CHIEF'S REPORT

Assistant Chief Shields presented Chief Carleton's Chief Officer Report, which was read and submitted.

In particular the first annual Hot Diggety Fun Run fundraiser was a great success.

Assistant Chief Shields also reported that Chief Carleton specifically asked that it be noted that the video recording of the July meeting experienced a malfunction at the 44 minute mark, and therefore he wanted to advise the public to rely on the written minutes as needed.

Assistant Chief then reported that new memory cards have been purchased for the video recording system.

He also reported that July had a record number of calls at 47.

Commissioner Harper asked if the perpetrators of the illegal burns were fined. Assistant Chief Shields noted that warning notices were issued to the offenders, and he then reviewed the process for reporting repeat offenders to the Fire Marshall's office and in some cases also reported to Clean Air for potential fines or other penalties. Discussion continued about illegal burns, known repeat offenders, and other individuals who skirt the regulations by burning at night or using other tactics. Commissioner Harper would like more information to be available to the public about the dangers of burning, and suggests that flyers be created to help disseminate the information in the community.

#### G. UNFINISHED BUSINESS

#### H. NEW BUSINESS

Commissioner Meursing indicated that he had been contacted by Chief Carleton who is currently attending a conference in Dallas, with the request that he be granted authority to act on behalf of WCFD5 in a potential purchase of a Class A Fire Pumper apparatus, as has been previously discussed and is described in the Capital Facilities Plan.

Commissioner Lester said that we have talked about this type of apparatus at great length and she has no problem granting Chief Carleton the authority to purchase a Class A Fire Pumper, if the opportunity should arise.

Commissioner Harper agreed that this issue has been discussed at great length and he too had no problem granting Chief Carleton the authority to purchase a Class A Fire Pumper, if the opportunity should arise

Commissioner Meursing agreed with Commissioners Lester and Harper and will give Chief the go ahead to pursue such opportunities.

#### ADJOURNMENT

As there was no further business, Commissioner Meursing moved to adjourn the meeting. Commissioner Lester seconded the motion. **Motion passed 3 – 0**
