# **MINUTES**

#### A. CALL TO ORDER

The meeting was called to order at 4:04 p.m. by Chairman Meursing.

#### B. PUBLIC COMMENT

Bruno Moras stood and reflected on some of the history of the Fire District, specifically the period when the District joined with North Whatcom, which he feels ended up being a costly decision for this community, and now that our district is disentangled from North Whatcom, everything has been running smoothly, the District and the Commission. A parallel consideration is that of our Hospital District, its' decision to hand over operations to an outside service provider, and the challenges they now face because of that decision. Mr. Moras ended by thanking the Commissioners and Chief for the job they are doing, and said that he will be bringing his observations to the next Hospital Board meeting as well.

John Lesow followed up Bruno Moras' comments, saying that he has a lengthy history in Point Roberts, over 25 years, and feels that it is a good idea to put all your eggs in one basket – and then watch the basket.

Commissioner Meursing responded by saying that essentially this District focuses on keeping people happy, healthy and protected from fire.

# C.1 Approval of the Minutes of the Regular Meeting of August 8, 2018

**MOTION:** Commissioner Lester moved to accept the Minutes of the Regular Meeting of August 8, 2018 as presented. The motion was seconded by Commissioner Harper. **Motion passed 3-0.**

Financial Manager Markel presented the monthly financial report as submitted.

### D. 2 Approval of Fire District Vouchers

**MOTION:** Commissioner Lester moved to accept the Vouchers in the amount of \$23,098.71 for payment. The motion was seconded by Commissioner Harper. **Motion passed 3** - **0** 

## D.3 Approval of Fire District Payroll

**MOTION:** Commissioner Lester moved that payroll in the amount of \$21,775.33 be approved for payment. The motion was seconded by Commissioner Harper. **Motion passed 3 – 0** 

#### D.6 Budget Update

Financial Manager Markel reported that 39.28% of the budget is remaining, compared to \$43.88% for the same period last year, the difference due to the insurance premiums being paid one month earlier this year than last year.

#### E. CORRESPONDENCE

Chief Carleton reported no correspondence at this time.

#### F. CHIEF'S REPORT

Chief Carleton's Chief Officer Report was read and submitted.

There were 41 calls in August, now at 241 calls for the year. Chief anticipates there might very well be over 300 calls by the end of the year, a record high for this District.

Commissioner Harper initiated a discussion about the roads and maps of Point Roberts, and Chief described how the District members ascertain the location of emergency calls.

Chief Carleton described how Canadians serve in our District, reviewing the prerequisite certifications, EMT training, and subsequent contractual obligation to the District.

#### G. UNFINISHED BUSINESS

None.

#### H. NEW BUSINESS

Chief Carleton announced that two dates should be discussed and set at this time. The Budget cycle is coming up, and is usually approved at the November regular meeting. Chief will be absent for the regularly scheduled November meeting and requests that the regular meeting of November be moved ahead one week to November 7<sup>th</sup>. After some further discussion, October 25<sup>th</sup> was proposed for the Budget workshop meeting at 4:00 pm. Everyone agreed to the two dates.

#### ADJOURNMENT

As there was no further business, Commissioner Meursing moved to adjourn the meeting. Commissioner Lester seconded the motion. **Motion passed 3-0**
