D.4 Budget Update

Financial Manager Market reported that 41.77% of the budget remained as of the end of September, compared with the September 2019 amount remaining of 38.84%. Financial Manager Markel also noted that the annual insurance policy premium has not yet paid, and therefore not included in this calculation.

Financial Manager Markel suggested a date be chosen for a Special Meeting, ahead of the next regular meeting to discuss the draft 2021 Budget.

District Secretary Hughes commented that the next scheduled Regular Meeting is on November 11th, but that date is also Veteran's Day. She suggested having the November Regular Meeting on November 10th. That date was agreeable to all parties.

The proposed Special Meeting was tentatively scheduled for November 3rd, however Chief Carleton indicated that he would have to check his schedule to confirm whether he could be available for that meeting.
