A. CALL TO ORDER

The meeting was called to order at 4:00 p.m. by Commissioner Lester.

B. PUBLIC COMMENT

C. BOARD ACTION

C1. Approval of the Minutes of the Regular Meeting of December 9th, 2020

MOTION: Commissioner Newmen moved to approve the Minutes of the December 9th meeting as presented. The motion was seconded by Commissioner Harper. **Motion passed 3–0**

D. FINANCIAL MANAGER'S REPORT

D.1 Financial Report

Financial Manager Markel presented the financial report as submitted.

Financial Manager Markel indicated that the December year-end would be available at the February meeting, as the County has not yet closed out its 2020 books to confirm the balances in the district accounts.

Commissioner Newmen asked about the \$13,820.05 expense noted on the financial report. Ms. Markel directed him to the itemization of items over \$1,000 on the district credit card including an expense of \$1,829.52 to Priceline Country Inn for Chief Carleton's accommodation while he attended the Alabama Fire College, as well as the cost of attending the Alabama Fire College.

D.2 Approval of Fire District Vouchers

MOTION: Commissioner Newmen moved to accept the Vouchers in the amount of \$21,987.85 for payment. The motion was seconded by Commissioner Harper. **Motion passed 3–0**

D.3 Approval of Fire District Payroll

MOTION: Commissioner Newmen moved that payroll in the amount of \$24,516.33 be approved for payment. The motion was seconded by Commissioner Harper. **Motion passed 3–0**

Financial Manager Markel reported that 14.49% of the budget remained as of the end of December, compared with the December 2019 amount remaining of 10.31%.

Chief Carleton's Chief Officer Report was read and submitted as presented, by Assistant Chief John Shields.

The Assistant Chief reported that Chief Carleton has been working closely with the clinic in an attempt to procure the Covid vaccine for Point Roberts.

Assistant Chief reported that there was a vehicle incident and that Chief Carleton is working with Kelly Insurance on the matter.

Commissioner Harper asked about the enclosure for the tower that is being erected at the Fire Hall and recommends cyclone fencing. Commissioner Newmen replied that he is currently pricing the cyclone fencing as an option.
